## **Scope OF Work**

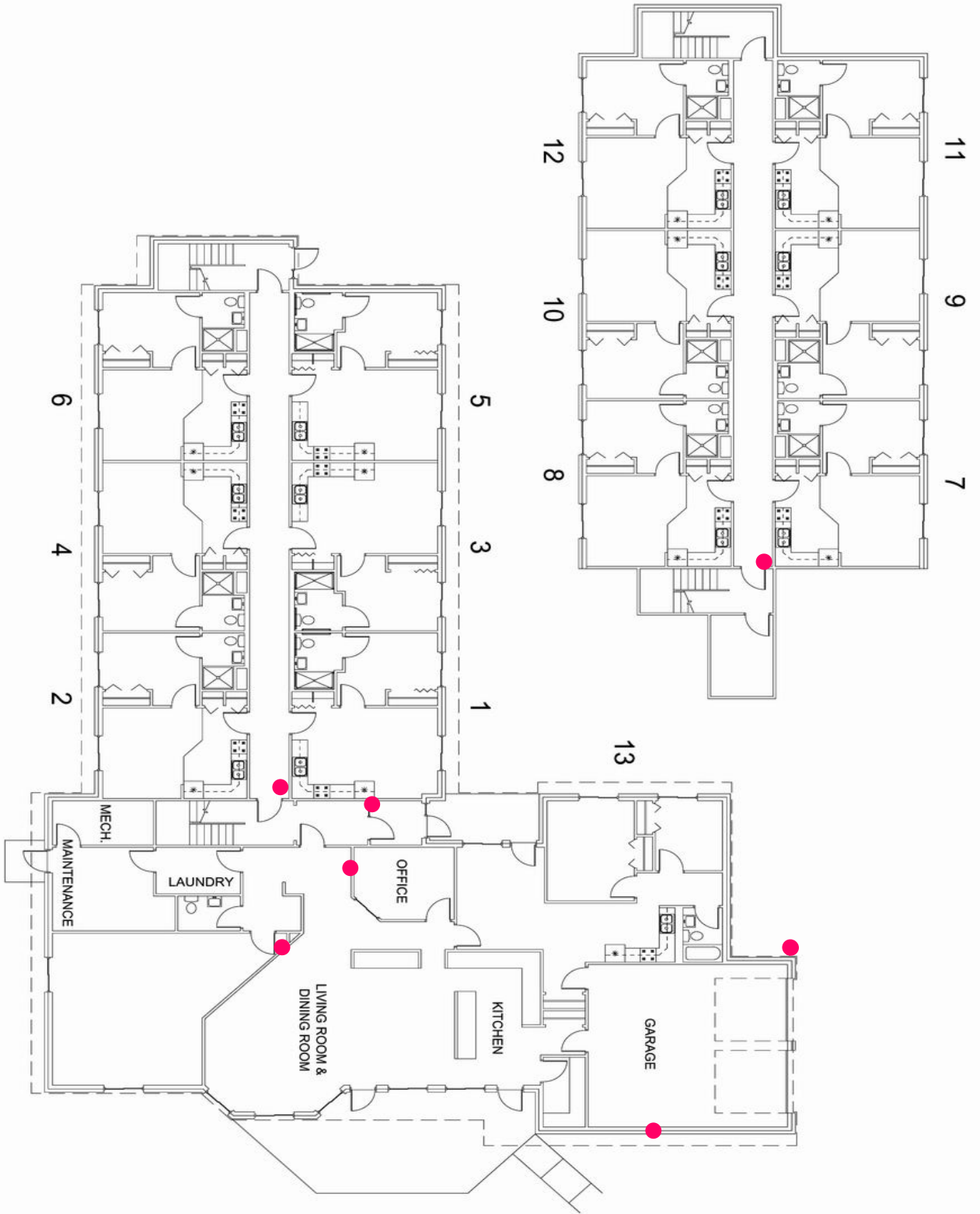
Furnish all labor, Equipment, and services required to complete all work for the install of Security Cameras located at:

823 W. Oakland Street known as Irvin apartments  
816 ½ W Washington Street known as Irvin Apartments

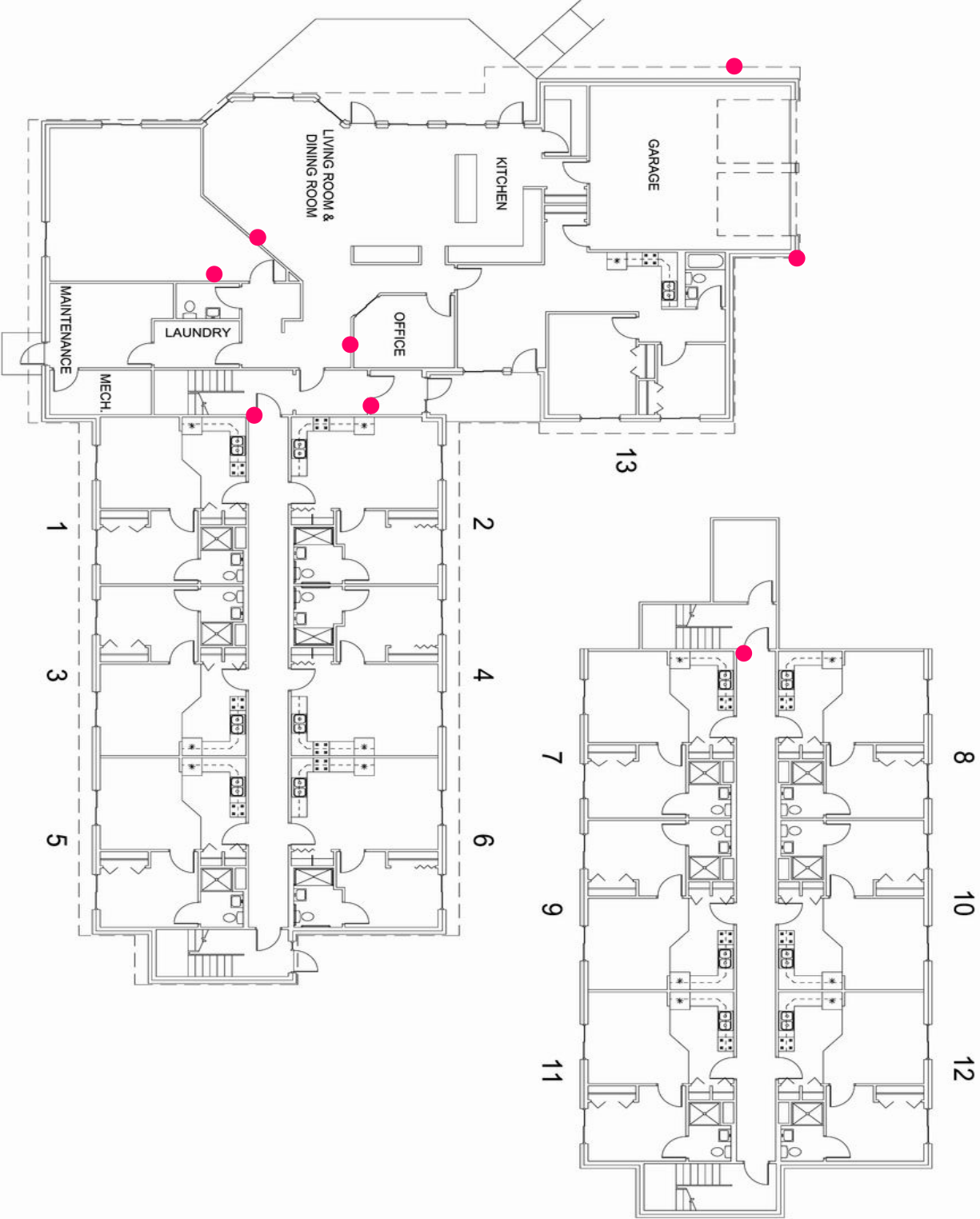
Material Specs:

- 1) One Lockable equipment rack with video recording/control, keyboard/mouse, monitor, and uninterruptible power supply located in south building mechanical room.  
With necessary equipment to send camera signal from north to south building via existing fiber optic cable
- 2) Four exterior 5MP, 104-degree view camera to cover parking lot (2 mounted per building)
- 3) One interior 2MP camera at entrance to each building (2)
- 4) one interior 5MP camera facing laundry room of each building. (2)
- 5) One interior 5MP camera at the end of the first-floor hall in each building (2)
- 6) One interior 5MP camera at the end of the second-floor hall in each building. (2)
- 7) One interior 5MP camera at the wall of the living room to cover the living and dinning rooms in each building. (2)
- 8) One interior 5MP camera in community room of south building. (1)

- 10) All wiring should be covered with conduit or approved wire mold
